1. What is the research study about?

You are invited to take part in this research study. The research study aims to develop an AI tool to help carers notice changes in people with intellectual disability and seek medical help when needed. The tool will also help them talk about the signs with health professionals, so they can make health plans. We will work with people with intellectual disability and their family, carers and disability support workers to co-design the AI tool and test it.

This is the first part of the research project which includes the co-design of the requirements for an AI reasoning tool with stakeholders. This stage includes stakeholder consultations, a scoping review, phone questionnaires with people with intellectual disability, online supporters survey and co-design workshops.

4. Do I have to take part in this research study?

Participation in this research study is voluntary. If you do not want to take part, you do not have to. If you decide to take part and later change your mind, you are free to withdraw from the study at any stage.

If you decide you want to take part in the research study, you will be asked to:

- Read the information carefully (ask questions if necessary);
- Provide verbal consent form if you decide to participate in the study;
- Take a copy of this form with you to keep.

5. What does participation in this research require, and are there any risks involved?

If you agree to participate you will be asked to complete the following research procedures.

Interview: An online video or telephone interview, and you will be asked questions about Health outcomes for people with intellectual disability, specifically the current system, gaps and challenges, what future systems should look like and the role of AI in improving care. The interview will take place using Teams or via the phone and will take approximately 40 minutes. With your permission the research team would like to audio/video record the interview. If you do not wish to be recorded but you would like to participate you advise the research team and written notes will be taken. If requested, we can conduct the interview with groups of participants from the same organisation.

Additional Costs and Reimbursement: There are no costs associated with participating in this research project, nor will you be paid. However, you will receive a \$50 gift card to reimburse you for any reasonable expenses while completing the in-depth interview.

Psychological Distress: You may feel that some of the questions we ask are stressful or upsetting. If you do not wish to answer a question, you may skip it and go to the next question, or you may stop immediately. If you become upset or distressed as a result of your participation in the research project, the research team will be able to arrange for counselling or other appropriate support. Alternatively, free contactable support services are included at section 9. Any counselling or support will be provided by qualified staff who are not members of the research team. This counselling will be provided free of charge.

6. What will happen to information about me?

By signing the consent form, you consent to the research team collecting and using information about you for the research study.

The research team will store the data collected from you for this research project for:

- A minimum of 7 years after the completion of the research;

The information about you will be stored in an/a:

- Re-identifiable format where any identifiers such as your name, address, date of birth will be replaced with a unique code.

You will be asked to provide your consent for the research team to share or use the information collected from you in future research that:

- Will be an extension of, or closely related to, the original project; or is in the same general area of research

Your decision not to participate or to withdraw from the study will not affect your relationship with UNSW Sydney or any of the organisations involved in this research. If you decide to leave the research study, the researchers will not collect additional information from you. You can request that any identifiable information about you be withdrawn from the research project.
